The meeting was called to order at 11:25 A.M. by Jack Kwesell, President.

## **Management Report:**

Marcel and Irina presented the Management Report.

Management met with a representative from Vermont Mutual for an inspection related to the master insurance policy.

WMO replaced the gas lines and related equipment at 6/8 Fox View in accordance with our contract replacement schedule of two systems a year. Management indicated that WMO communication with respect to this activity could have been better. WMO communication remains an ongoing issue.

14 Georgia Lane – the roof is still an issue. All units in this building have had leaks which have been addressed but the roof needs replacement. A leak weakened the sheetrock behind the cedar paneling in unit 14A resulting in a piece of the paneling falling off. 14 and 10 Georgia Lane and 180 Main Street are reroofing priorities. The roof on 12 Cottage Drive is holding.

Smoke from 6B/6C – despite the installation of dampers, smoke is still flowing from one unit to another. Rebuilding the chimneys is estimated at \$30,000-40,000. Marcel is investigating liners as a cost effective alternate. The Board approved the cost of a camera survey of the chimneys.

The cherry picker used for painting/repairs at 3/5 Fairview may have damaged the walkway at 5 Fairview. We will wait until spring to determine extent of repairs required.

The dead pine tree behind 29A Wentworth Hall Ave. was removed by the golf course.

## **Financial Report:**

We don't have the financial information for this month. Irina will send out the bills on December 10<sup>th</sup> instead of the 15<sup>th</sup> to help with cash flow.
